COVID-19 Vaccine Information

Although children in general are at less risk from COVID-19, Children and Youth with Special Health Care Needs (CYSHCN) may be at [increased risk](#) for severe illness with COVID-19. Below is information on options for accessing vaccinations in Washington State for CYSHCN, their families, and providers.

When Can My Child Get Vaccinated?

- Right now, there are no vaccines approved for children under 16
- **NEW!** Youth 16 years or older with down syndrome, a development disability, intellectual disability, or are deaf/hard of hearing, blind/low-vision, or deafblind AND that disability or an underlying condition increases their risk for severe [outcomes](#) are [eligible](#) in [Phase 1B Tier 2](#). This phase started on March 17th.
- Those with 2 or more comorbidities or underlying [conditions](#) are eligible in [Phase 1B Tier 3](#) which is expected to begin on March 31st. Those with only one [condition](#) are eligible sometime in Phase 2 which is expected to begin May 1st. Further details on Phase 2 are not out yet.
- Certain vaccines may not be appropriate for youth with specific [conditions](#) such as allergies to ingredients in the vaccine. Contact your child's health care provider for more information.
- If your child lives in a congregate residential setting they are eligible to be vaccinated now as part of [Phase 1A](#)

When Can I Get Vaccinated to Protect Myself and My Child?

- **NEW!** You are now eligible in [Phase 1A](#) if your child has an underlying health condition or disability that puts them at high risk for severe COVID-19 illness and they need caregiving support for their daily, functioning, and health needs. Visit [Phase Finder](#) and **answer "yes" to the question that asks if you a worker in a health care setting**. It will give you a confirmation that you are eligible that you can print out and take to a [vaccine provider](#).
- If your child is over 18 **and** you are contracted with the Department of Social and Health Services (DSHS) as their personal care provider, you can also download the [DSHS Vaccine Verification Letter](#) to bring to a [vaccine provider](#) (find out more information [here](#)).

What about the Providers that Work with my Child?

Healthcare Providers

- Healthcare providers are eligible now during [Phase 1A](#). This includes speech (SLP), occupational (OT), and physical therapists (PT), Applied Behavior Analysis (ABA), mental health, and early intervention (Early Support for Infants and Toddlers – ESIT) providers.
- Providers that are affiliated with a healthcare organization that is [administering the vaccines](#) can get a vaccine from their organization.

- Other providers can use [Phase Finder](#) or get a [voucher letter](#) from their employer that they can take to a [vaccination site](#) to get vaccinated.

Personal Care and Respite Providers

- If your child has providers that are contracted DSHS Developmental Disabilities Administration (DDA) providers, they are eligible now as part of Phase 1A. They can find out more information [here](#) and download the [DSHS Vaccine Verification Letter](#) to bring to a [vaccination site](#).

Teachers and School Staff

- **NEW!** Child care providers and school staff are now eligible [Phase 1B Tier 1](#).

I'm Eligible! How do I get my vaccination?

- Visit [Phase Finder](#) or **call 1-800-525-0127** to confirm eligibility and find [places](#) to get vaccinated.
- If you are a DSHS contracted provider, download the [DSHS Vaccine Verification Letter](#) to bring to an enrolled vaccine provider.
- The Centers for Disease Control and Prevention created [Pharmacy Partnership Programs](#), to assist with vaccinations for long term care, education, and other priority populations.

How Much Will it Cost to Get Vaccinated

- The federal government will cover the full cost of the vaccine. You should not be charged out of pocket costs or receive a bill from your provider for the COVID-19 vaccine. This applies to people who have private insurance, Apple Health (Medicaid), Medicare, or are uninsured.
- You should not be charged for an office visit if you only receive the vaccine. If other services are performed along with the administration of the vaccine, it may be billed as an office visit. If you get charged for the vaccine, contact your insurance plan first. Please also email covid.vaccine@doh.wa.gov. If contacting your insurance plan doesn't address the issue, you can also [file a complaint](#) with the state Office of the Insurance Commissioner.
